NACO Scholarship Applications Are Now Open

Each year, the NACO Board endows 12 \$1,000 scholarships for high school seniors who are children of county officials and employees

To be considered, students must complete the required application form, submit a seven-semester transcript from an accredited Nebraska high school and prepare a written essay on the importance of county government.

Scholarship recipients must plan to attend a post-secondary educational institution within the state of Nebraska and may use the NACO scholarship for any costs associated with their continuing education.

Rural Nebraska Historic Preservation Program Grant Opportunity

The Rural Nebraska Historic Preservation (RNHP) program will provide grants to owners of historic properties in rural Nebraska communities. The program is funded through a competitive sub-grant program from the National Park Service. Nebraska was among eleven other recipients to receive funding from the Paul Bruhn Historic Revitalization Grants Program. History Nebraska, through the Nebraska State Historic Preservation Office (SHPO), was awarded \$350,000 to support the RNHP sub-grant program (P22AP01544). Of the initial award, \$328,000 will be made available for sub-grant awards.

The objective of the Rural Nebraska Historic Preservation Grant Program is to support the rehabilitation of historic structures at the national, state, and local levels of significance in order to rehabilitate, protect, and foster

economic development in rural communities. This program will fund physical preservation projects, including architectural and engineering consultation (up to 20% of the total project cost) for historic sites located in Nebraska's rural communities with a population of less than 30,000.

- .gov Email: Microsoft Exchange online or Google Workspace required for all County Staff and Supervisors.
- · Email Security / CSAT (cyber security awareness training): Suggested platforms include scanning and antiphishing functionality. Suggested vendors: IronScales, Knowbe4, Barracuda, ProofPoint, etc
- County Network (OCIO separation): All County owned systems connected to separate County LAN, VLAN segregation of CJIS, proper State application routing via OCIO firewall. OCIO (Office of the Chief Information Officer - State of Nebraska)
- Wireless Networks: Secure and separate guest and private networks. Cloud managed platform with portal login or frequent password rotation.
- Firewall Licensed NGFW (next generation firewall appliance) with cyber licensing. Suggested vendors: Fortinet, WatchGuard, SonicWALL, Cisco Meraki, Palo Alto
- Vulnerability Management Perimeter: Perimeter network scanning. Suggested vendors: CISA CyHy, Qualys.
- Endpoint Protection: Managed commercial endpoint protection. Portal management and enforcement. Suggested vendors: BitDefender, Webroot, Cylance, SentinelOne, Defender, ESET, Sophos.
- Patch Management: Enforced and frequent patching of OS and critical 3rd party softwares: WSUS, RMM (ie: Ninja RMM, ConnectWise Control, Atera).
- MFA (multi factor authentication): Enforcement of MFA on all remote access and County email platforms.
- Backup: Minimum onsite disk rotation backup (ie: Shadow Protect by MIPS). Backup of all critical data.
- Backup Advanced: Automated cloud backup system with onsite/cloud storage. Monitored. Includes business continuity features. Suggested vendors: Axcient, Veeam, Datto.
- · County Network / System Authentication: User of local Microsoft active directory services or Azure active airectory for County desktops, laptops and servers.
- Endpoint Protection Advanced: Advanced endpoint protection with detection/response features. Suggested vendors: SentinelOne, CylancePROTECT, Crowdstrike, Huntress.
- Password Manager: Managed commercial password manager for all County staff. Suggested vendors: LastPass, Keeper, BitWarden.
- M365 Backup and Archiving: Backup of cloud hosted email and document systems. Suggested vendors: DropSuite, x360 Cloud.
- MFA Advanced: Managed advanced commercial MFA platform. MFA on key infrastructure: Servers, Firewalls. Suggested vendors: DUO.
- · Vulnerability Management Endpoint: Internal network and endpoint vulnerability scanning and assessment. Suggested vendors: CISA, Qualys.
- Log Analysis (SIEM) w/ SOC Monitoring: Managed log analysis for servers, Azure, firewall and optionally endpoints. Suggested vendors: EventTracker, ConnectWise SIEM.
- Endpoint Protection w/ SOC Monitoring: Managed endpoint protection to include security operations center monitoring, alerting, response and remediation services.
- Centralized Network Environment: Ethernet cabling home run to centralized IT rack(s) to allow for proper network VLAN (virtual LAN) and LAN segregation (ie, private county, private state, CJIS, public networks) via managed network switching and firewall equipment.

Galloway selected as Fellow on Reaching Rural Initiative Collaborative

Fairbury, Nebraska, (January 4, 2023) — The U.S. Department of Justice, Bureau of Justice Assistance (BJA) announced Peggy Galloway, Director of Jefferson County Diversion and Pretrial Services in Fairbury was chosen to be part of a select group of fellows in a new rural leadership program. It's called *Reaching* Rural: Advancing Collaborative Solutions. Program fellows will learn how to adopt bold solutions to the persistent challenge of substance use in rural communities. They'll work closely with innovators who have established successful programs in other rural communities.

The participants were selected through a competitive process. "I am very excited to be part of this initiative," said Galloway. "This is a great opportunity for finding programs that work in other rural communities so that we can develop similar programs here in Jefferson County."

The year-long program, which kicked off in December, will have a strong focus on creating engagement across rural communities and sectors. Over the course of the year, participants will benefit from virtual and in-person learning opportunities which include coaching, skill-building workshops, and local and regional asset mapping. The program will demonstrate how diverse systems with different missions can engage with one another to serve justice-involved individuals more effectively with substance use or cooccurring disorders.

About The Reaching Rural Initiative

The Reaching Rural: Advancing Collaborative Solutions initiative is a collaborative project providing training to a class of over 65 fellows working to adopt bold solutions to the persistent challenge of substance use and misuse in 81 rural communities across 15 states. The fellows include elected county leaders, county and tribal judges, law enforcement officers, prosecutors, public defenders, public health and behavioral health practitioners, emergency management professionals, reentry coordinators, and individuals working in community nonprofits.

The U.S. Department of Justice, Bureau of Justice Assistance (BJA), the Centers for Disease Control and Prevention (CDC), the State Justice Institute (SJI), with support from the Institute for Intergovernmental Research co-sponsor the project.
