Is your county prepared for a cyberattack?







In response to the growing threat landscape and complexity of the interdependent and networked business of counties, the NACo County Tech Xchange is partnering with the Professional Development Academy and their community of CISOs, CIOS, risk managers and cyber leaders to launch cyberattack simulation training.

The NACo Cyberattack Simulation is a reality-based simulation that prepares county risk leaders for cyberattacks by assessing counties' current state of readiness and identifying gaps. This simulation will help attendees evaluate their incident response procedures and tools and guide them in developing a detailed cyberattack response strategy.

COURSE OBJECTIVES:

- Provide a certified test of incident management plans.
- Baseline current cybersecurity and risk management work capabilities.
- Strengthen the leadership skills of managers responsible for risk planning and incident resolution.
- Improve the quality of the incident management plans and playbook details.
- Develop immediate action plans to strengthen people, process, and technical security controls.

WHO SHOULD PARTICIPATE?

The NACo Cyberattack Simulation is designed for cybersecurity managers, their teams and those responsible for risk defense, protection, and recovery, including HR, policy management, finance, public safety, and emergency services.

WHAT IS THE TIME COMMITMENT?

30-60 minutes per day for one week. Activities can be completed on the participants' schedule and accessed online anywhere.

WHAT IS THE COST?

The retail price of the one week Cyberattack Simulation is \$795 per enrollee; however, the simulations are fully sponsored for all counties, bringing your price down to no cost.





Bridge Investment Program (BIP) Notice of Funding Opportunity (NOFO) Large Bridge Projects

A Notice of Funding Opportunity (NOFO), link below, for the Bridge Investment Program (BIP) Large Bridge Project grants (costs greater than \$100 million) was published on September 27, 2023, on www.grants.gov.

A separate NOFO for the other two BIP categories, Planning Project Grants and Bridge Project Grants (Costs not greater than \$100 million), will be issued in the near future. Information on the program is available at <u>BIP - Funding Programs - Management and Preservation - Bridges & Structures - Federal Highway Administration (dot.gov)</u>, which includes a link to the NOFO, a fact sheet on the BIP, and an initial set of Q&As.

In the near future, links for an application template and a Benefit-Cost Analysis (BCA) tool will also be provided. Additional information and guidance will be posted to the website in the near future including a recorded webinar that provides an overview of the BIP.

Nebraska Broadband Office Invites Comment on New Statewide Broadband Map

Do You Receive Access to High-Speed Internet?

As part of the Broadband, Equity, Access, and Deployment (BEAD) program, the Nebraska Broadband Office has launched the State Broadband Availability Map, which identifies the served, underserved, and unserved locations across the state. Unserved locations identified on the map will be prioritized to receive broadband buildout in this program. If there is an error, you must challenge the map to fix it. To verify your level of Internet Service, visit the Nebraska Broadband Map (LINK).

To ensure that Nebraska has access to federal funding opportunities, it is essential that the map reflects all the unserved and underserved broadband serviceable locations. As part of the map availability, there will be ongoing public engagement across the state including a series of eight public meetings and an open comment period from Sept. 14 to Oct 14. Details can be found at (LINK).

The Office will only accept challenges from:

- nonprofit organizations;
- I local and tribal governments; and
- broadband service providers.

Nebraskans may submit a challenge by contacting their local government or Regional Economic Development District (EDD) serving their county. The local government or EDD will then submit the challenge on behalf of the residents. A challenge guide will be made available on December 22, 2023, prior to the start of the Challenge Period in early January.
