Flags to Fly at Half-Staff in Honor of Patriot Day

LINCOLN, NE – September 7, 2023 - Today, Governor Jim Pillen announced that all U.S. and Nebraska flags are to be flown at half-staff on Patriot Day, September 11, 2023. Flags should be flown at half-staff from sunrise until sunset on that date.

"September 11 marks a solemn day in our nation's history – one that will never be forgotten," said Gov. Pillen. "That date will be marked with many fitting remembrances. Twenty-two years have passed, but our memories have barely dimmed. By lowering our flags, we pay tribute to those who perished, we honor the heroes, and we acknowledge the service of our military men and women, who have also made sacrifices so that we can continue to live under a banner of freedom today."

FEMA and FCC Plan Nationwide Emergency Alert Test Oct. 4.

FEMA, in coordination with the Federal Communications Commission (FCC), will conduct a <u>nationwide test</u> of the <u>Emergency Alert System</u> (EAS) and <u>Wireless</u> <u>Emergency Alerts</u> (WEA) on Oct. 4.

The national test will consist of two portions, testing WEA and EAS capabilities. Both tests are scheduled to begin at approximately 2:20 p.m. ET on Wednesday, Oct. 4.

The WEA portion of the test will be directed to all consumer cell phones and will be the third nationwide test, but the second test to all cellular devices. The test message will display in either English or Spanish, depending on the language settings of the wireless handset. The EAS portion of the test will be sent to radios and televisions. This will be the seventh nationwide EAS test.
