
Thomas County has partnered with Thedford Village for a subgrant in the amount of \$35,000.

The funding will pay to bring the interior of the Thedford's water holding tanks up to code. Without the funding, the estimated cost would be a 56% fee increase that would fall on the village taxpayers. The village has also received ARPA funds and will also be applying their funds to the project. The Thomas County Board of Commissioners approved the request and will disburse funds when the project is completed.

Thomas County also recently agreed on some parameters for other subgranting funds and currently have three applicants for small businesses in the area.

PMA Asset Management: Higher Rates and Treasury Securities

Dramatic developments around the globe remind us that market drivers are frequently unexpected events. Factors domestic and abroad have increased market rates significantly in 2022. Rising interest rates have provided opportunities for public entities who have the ability to invest longer term. Especially with today's steep yield curve, investors in longer term securities are earning substantially greater interest income from higher longer–term yields compared to investors focused only on short–term investments such as money market funds and overnight bank deposits.

With good planning, public entities can increase investment income for their communities through market cycles. A strategy for growing investment income is building laddered portfolios with investment maturities at regular intervals. Investors in marketable securities such as U.S. Treasury securities should be aware of GASB requirements to mark investments to market. Importantly, these unrealized gains and losses are only realized if the security is sold prior to maturity.

New IAAO self-study course - GROW into Coaching


The first self-study course in Emerging Leaders' curriculum has been released. Old command and control leadership methods no longer service employees or organizational growth. According to the Harvard Business Review, managers who practice a coaching leadership style ask questions instead of providing answers, support employees instead of criticizing them, and help enable employee development through empowerment.

Participants in this self-paced program focus on leading through coaching. The GROW Coaching Model and a growth mindset are emphasized.

Registrants gain access to three eLearning modules: engaging activities, supplementary materials, and a copy of the book "Coaching for Performance" by Sir John Whitmore, referenced throughout the course.

The program cost is \$249 for IAAO members and \$329 for nonmembers.
