## NACo Rural Energy Academy Launches New Technical Assistance Cohort

NACo's Rural Energy Academy is excited to launch a new technical assistance cohort.

The Rural Energy Academy is a **free three-month technical assistance cohort designed for rural counties navigating wind, solar, and/or battery energy storage systems (BESS)**. ## Now Accepting Interim Policy Resolutions for the 2026 NACo Legislative Conference

Members are encouraged to get involved and have their voices heard in Washington by [submitting an interim policy resolution](#).

**Why it matters:** The resolutions process allows counties to participate directly in national policy decisions affecting county governments. During the [2026 Legislative Conference](#), NACo's 10 policy steering committees and Board of Directors will consider legislative and policy resolutions to guide advocacy until the Annual Conference in July.

**Submit a resolution:** All interim policy resolutions must be submitted electronically by Tuesday, Jan. 20, using the [online submission form](#).

## Reorganization Meetings to Occur in January 2026

In supervisor counties, the regular meetings of the county board are to be held in January. At its regular meeting of each year, the board must organize by choosing one of its number as chairman, who shall preside at all meetings of the board during the year; in case of his absence at any meeting, the members present must choose one of their number as temporary chairperson. Sections 23-272, 23-274. Similarly, Neb. Rev. Stat. § 23-156 provides the board of county commissioners at its regular meeting in January of each year must elect a chairperson of the board to serve for the ensuing year, and such chairperson shall sign all warrants on the treasurer for money to be paid out of the county treasury.

An individual can vote for himself or herself for county board chair. See [Nebraska Accountability and Disclosure Commission \(NADC\) Advisory Opinion #202](#), adopted by the Commission June 2017 addresses a series of questions related to conflicts of interest, financial gain and compensation. County board members may vote for themselves for the position of

chair of the county board even if the chair has a higher salary. There are no “financial gain” and no conflict of interest involved in such a vote where the enhanced compensation for the chair is compensation provided by law.

## Grant Opportunity: 2026 AARP Community Challenge

The AARP Community Challenge grant program is now open for its 10th year! This initiative funds quick-action projects that make communities more livable and spark long-term change.

**Eligibility:** 501(c)(3), 501(c)(4), 501(c)(6) nonprofit organizations, government entities, and other organizations on a case-by-case basis

### 2026 Grant Opportunities:

#### *Flagship Grants*

Support projects that improve **public places; transportation; housing; digital connections; and disaster resilience**. Awards range from a few hundred dollars to \$15,000.

#### *Capacity-Building Microgrants*

\$2,500 grants paired with expert support, webinars, and cohort learning. Focus areas include **walk audits, bike audits, HomeFit® Guide modifications, and disaster preparedness training**.

#### *Demonstration Grants*

Designed to replicate promising local efforts. Topics include **pedestrian safety (funding support from Toyota Motor North America), high-speed internet (funding support from Microsoft), and housing design competitions**. Awards typically range from \$10,000-\$20,000, and will not exceed \$25,000.

Since 2017, AARP has awarded over \$24.3 million through 2,100 grants across all 50 states, D.C, Puerto Rico, and the U.S. Virgin Islands. Many projects have gone on to attract additional funding, influence local policy, and inspire replication.
