## **Group Term Life Insurance**

As a member of the NACO-sponsored benefit program enrolled in the BlueCross BlueShield (BCBS) medical and/or dental plan, you will automatically receive \$15,000 basic life insurance underwritten by Madison National Life Insurance Company, Inc. for all full-time employees that are enrolled in the BlueCross BlueShield medical plan. You can choose to solely offer this plan or opt for a higher benefit level at NACO-sponsored rates.

## **Basic Employer-Paid Group Term Life Insurance**

- **Eligibility:** Employees must be actively working a minimum 17.5 hours per week. This requirement does not apply to elected officials.
- Reductions/Terminations: Benefit will reduce to 65% upon the insured employee's attainment of age 65, reduces to 45% at age 70, reduces to 30% at age 75, and will terminate upon retirement.
- Additional Line of Duty Benefit: A Line of Duty
  Benefit would be payable if an employee is a public
  safety officer, suffers a loss for which an AD&D benefit
  is payable, and the loss is a result of a Line of Duty
  Accident.
