Strong and Unique Passwords:

1. Complexity Matters:

Cooperative

- Use a mix of uppercase and lowercase letters, numbers, and special characters.
- Avoid common words or easily guessable patterns.
- 2. Unique for Each Account:
 - Never reuse passwords across different platforms.
 - If one account is compromised, others remain secure.
- Consider Passphrases:
 - Combine random words or phrases to create longer, memorable passwords.
 - For example: "BlueSky\$Coffee@2023!"

Strong passwords are your first line of defense against cyber threats!



Cyber Secure: When working remotely, prioritize cybersecurity. Install software updates promptly, and use a VPN for secure connections, especially

when using public Wi-Fi. Create strong, unique passwords and secure your home network. Stay informed about common threats and best practices to keep your

A Virtual Private Network (VPN) is crucial for remote workers. Here's why:

1. Securely Transmit Data:

- A VPN encrypts your internet traffic.
- It ensures that sensitive information (like login credentials or company data) remains confidential.

The NACo ARPA State and Local Fiscal Recovery Fund Obligation Updates and Guidance resource provides an in-depth overview of the flexibilities provided by the U.S. Department of Treasury's obligation guidance for the ARPA State and Local Fiscal Recovery Fund.

NACo tirelessly advocated for the additional flexibilities and protected them from repeal last month via a Senate Congressional Review Act (CRA) vote. The overview provides additional clarification on some key topics including obligations around personnel expenses, reclassifying funds and subrecipients.
