Registration for the County Official Online Learning (COOL) Network closes soon!

If you're a newly elected or appointed county official, this course is a great opportunity to connect with other county officials, university professors, and local government experts through self-paced online content, discussion forums, weekly live webinars, and a final inperson session. **The enrollment deadline is April 15**, so <u>register now to secure your spot</u>.

The COOL Network is a hybrid educational course that includes a three-week online session in May, followed by one in-person session in Kearney, NE, on June 4, 2025. **Topics covered will include:** 

- The purpose, structure, and funding of county government

- Government finance, expenditures, and mandates
- Courthouse infrastructure, Information Technology risk management
- Visioning and strategic planning

This course provides an excellent transition to the Institute of Excellence, a professional development program for county officials designed to cover topics such as county data exploration, leadership, and community engagement. The Institute of Excellence kicks off in August, so be on the lookout for registration details this summer.
