## BEAD Update - Public Input Requested

After sweeping federal rule changes upended the Broadband Equity, Access, and Deployment (BEAD) program last summer, Nebraska was left with over \$320 million in unawarded funds. Recent clarifying statements from the Department of Commerce and NTIA representatives affirmed that Nebraska can utilize these funds to support the efficient deployment of funded broadband projects, ensure widespread adoption and utilization, and advance robust and secure communications infrastructure. As integral parts of Nebraska's broadband expansion process, counties are well-positioned to implement key non-deployment programs and may benefit from this funding.

The Administration is now seeking public input on eligible projects and program guidelines for BEAD non-deployment funds. Examples of recommended uses include the following:

- Public safety projects, including next-generation 911, interoperability, and emergency communications equipment upgrades.
- Initiatives to streamline utility permitting processes.
- Digital skills training and broadband adoption promotion.
- Workforce development, training, and apprenticeship programs.
- Specific broadband applications, such as precision agriculture and telehealth.
