SFY2026 Title II Formula Grant Program

The Nebraska Commission on Law Enforcement and Criminal Justice is pleased to announce the availability of the **SFY2026 Title II Formula Grant Program.** The Notice of Funding Opportunity (NOFO) outlines general guidelines, eligibility, funding requirements, and application instructions. Please read the NOFO thoroughly to ensure all requirements are met in the application. This application form, funding priorities, and required attachments are different than the state grants (CBA, EB, JS) so make sure to check all requirements carefully. SFY2026 TITLE II FORMULA GRANT PROGRAM: \$409,122

The maximum award by category is listed below. There is no match required under this program:

Delinquency Prevention - \$195,249

Positive Youth Development - \$139,660

Juvenile Justice System Improvement - \$74,213

Eligible applicants include state and local government agencies, state and federally recognized Indian tribes, and nonprofit organizations providing direct services to at-risk youth and youth involved in the juvenile justice system. Priority will be given to applications that implement evidence-based programs and promising practices.
