Hotel Reservation Process for Annual Conference

All hotel reservations must be made using this online form. Reservations will not be accepted by calling the front desk. Please note that the hotel reservation form is NOT your registration as an attendee for the annual conference. You'll also need to register if you plan to attend (see registration details below).

1) The online reservation form will be emailed to ALL COUNTY OFFICIALS, made available on the NACO homepage and on the <u>conference webpage</u> on Wednesday, September 11th, at approximately 1:30 P.M. 3) After you submit the form, the contact person listed on the form will receive an email in return with a copy of their submission.

4) Reservations will be made based on the order of form submission by the Younes Center. The hotel's front desk staff will then reach out the contact person listed on the form by email to inform them which hotel your county has been placed in to take care of billing information, rooming lists, and confirmation numbers. Please note that your preferred hotel is not guaranteed.

5) If you are reserving multiple rooms for your county, you must provide a rooming list with guest names and stay dates to the Younes Team by October 11th. Any unclaimed rooms after October 11th will be placed back into the general NACO block for other attendees/counties to reserve. Tip: If arrival times for your group are different, please select the maximum stay range for everyone on the form and let the hotel staff know of your date changes when presenting the rooming list.

Low-Carbon Transportation Materials Program NOFO

The Low-Carbon Transportation Materials (LCTM) Program Notice of Funding Opportunity (NOFO) has been posted. This NOFO is open to non-State Department of Transportation (DOT) eligible recipients including local governments, political subdivisions of a State, US territories, Federally recognized tribes, Federal Land Management Agencies, Metropolitan Planning Organizations, and special purpose districts or public authorities with a transportation function. State DOTs were eligible to apply for this funding through a Request for Application (RFA) that closed on June 10, 2024.

The LCTM Program was authorized in Section 60506 of the Inflation Reduction Act with the purpose of increasing the use of materials that have "substantially lower levels of embodied greenhouse gas emissions" as described by the Environmental Protection Agency. FHWA will award up to \$800 million to eligible non-State DOT entities through the NOFO.

Application materials from eligible non-State DOT entities must be submitted through grants.gov by November 25, 2024, at 11:59 p.m., EDT. You may find additional information on the NOFO and the LCTM Program here: Low-Carbon Transportation Materials Grants Program.
