a seven-semester transcript from an accredited Nebraska high school and prepare a written essay on the importance of county government.

Scholarship recipients must plan to attend a post-secondary educational institution within the state of Nebraska and may use the scholarship for any costs associated with their continuing education.

## County Resource: Surplus Property

*The following information is provided as a resource for counties looking for surplus property solutions.*

The Materiel Division, Surplus Property processes surplus items per Neb. Rev. Stat. §81-161.04, providing agencies, political subdivisions, and the public with affordable used equipment. Items range from vehicles and computers to office furniture, with inventory available at [GovDeals.com/Nebraska](https://GovDeals.com/Nebraska).

Counties can also sell excess items through Surplus Property for an 8% commission, helping to recycle equipment and reduce storage needs.

### Important Considerations for Counties

All purchases and sales are subject to the requirements of the County Purchasing Act:

Purchases through Surplus Property are made via auction procedures and are not considered purchases off of the state bid (§ 23-3109).

Sales of surplus property must follow the thresholds and procedures outlined in § 23-3115.
