Legislative Interim Studies Scheduled

The Legislature's standing committees have begun scheduling public hearings in September and October on interim study resolutions. Some resolutions are a deeper dive into bills that were introduced during the last session and others are ideas for bills that will be introduced in 2026.

On September 19, the committee will hear [LR225](#) that would examine the need for a Green Amendment that was proposed as [LR22CA](#) during the 2025 session. LR22CA, if passed by the Legislature and adopted by voters, would require the state and political subdivisions to serve as trustees for the state's natural resources.

Hearings are scheduled in October on the Open Meetings Act ([LR192](#)), unfunded mandates ([LR195](#)), county initiatives and referendums ([LR253](#)), and riparian weed control funding ([LR168](#)). A full list of hearing dates and locations can be found [here](#).

Some hearings are limited to invited testimony, but public comments are accepted through the online comment button for each resolution.

What Borrowers Need to Know:

- As of August 1, 2025, student loan interest began accruing again for the nearly 8 million borrowers enrolled in the Saving on a Valuable Education (SAVE) Plan.
- The future of the SAVE Plan remains uncertain. In the meantime, interest is now being added to loan balances, though forbearances that pause payments remain in effect.
- While no immediate action is required, borrowers looking to avoid accumulating interest may want to switch to an active repayment plan. You can explore your options and [enroll directly through your Savi account.](#)

Collective Bargaining for Elected Officials

Elected officials serving on boards/councils/commissions may not have prior experience with or understand the role of labor unions and the collective bargaining process. Knowing how the collective bargaining process operates and its impact on the organization's employees and the taxpayers they represent is a critical duty for elected officials.

As such, the [William Brennan Institute for Labor Studies \(WBILS\)](#) has developed an e-learning (asynchronous) module to inform elected officials in the state of Nebraska with public sector unions who ultimately vote on collective bargaining agreements. The course, **Collective Bargaining for Nebraska Elected Officials**, covers several different topics, including why organized labor exists, labor law (federal and state, including the CIR), unfair labor practices, and the collective bargaining process and its different phases in negotiating wages/hours/terms and conditions of employment.

COLLECTIVE BARGAINING FOR NEBRASKA'S ELECTED OFFICIALS



Course Description

This course provides elected officials in Nebraska with a foundational understanding of labor unions, collective bargaining principles, and the legal frameworks governing labor negotiations within their state. Lessons cover the role of unions, good faith bargaining, unfair labor practices, and the distinctions between mandatory, permissive, and illegal bargaining subjects. By the end of the course, learners will be able to navigate labor negotiations with confidence while ensuring compliance with state and federal laws.

Learning Objectives

1. Identify the purpose of labor unions and key principles of collective bargaining
2. Explain Nebraska's collective bargaining laws and their function in labor relations
3. Apply principles of good faith bargaining to recognize unfair labor practices

Target Learner

This course is designed for elected officials in Nebraska who are responsible for overseeing or participating in public-sector labor negotiations. It is particularly beneficial for individuals seeking to better understand the legal and procedural aspects of collective bargaining and their role in ensuring fair and effective negotiations. No prior experience in labor relations is required.
