CISA National Director visit to Douglas County Election Office





It was an honor for the Douglas County Election Commission and Election Commissioner, Brian W. Kruse to host Director Jen Easterly and other Cybersecurity and Infrastructure Agency (CISA) representatives while they were in Omaha, on Tuesday, October 8th. Commissioner Kruse showed Director Easterly how elections are safe, secure, fair and accurate at the local level.

Director Easterly was appointed by President Biden and unanimously confirmed by Congress, April 2021. CISA is under the Dept. of Homeland Security.

LB1204 Local Tobacco License Report

<u>LB 1204</u> passed earlier this year now requires county clerks to report to the Nebraska Department of Revenue (DOR) the notification of granting a local tobacco license.

The initial report from the counties for 2025 will be due January 31, 2025.

This report must be filed even if the county has no tobacco licensees. Nebraska Department of Revenue is in the process of finalizing the reporting method. It will be done either through the electronic document and application hub (eDASH) or DOR's secure file sharing system.

Cyber Security Key Points October: Social Engineering



Cooperative



Pretexting:

False Identity Tactics

Hackers may impersonate co-workers or authority figures, creating a fake scenario (pretext) to request sensitive data. Verify any such requests via another communication channel before acting on them.



Spear Phishing

Unlike general phishing, spear phishing uses personal information to craft highly targeted attacks. Hackers may know details about your role or recent activities—always verify unexpected messages, even if they seem familiar.



Social Media Reconnaissance

Social engineers gather information from social media profiles to craft attacks. Publicly shared information about your job, hobbies, or friends can be used to manipulate you. Be mindful of what you post online.

Voice-Based Phishing


Hackers may use phone calls (vishing) to trick you into revealing sensitive info, pretending to be your bank or company's IT department. Hang up and call the official number to verify the request.




