### Local Governments Request DHS Transparency on Sanctuary Designations

NACo, the International Municipal Lawyers Association and the National League of Cities <u>sent a joint letter</u> to the Department of Homeland Security (DHS) and Department of Justice urging clarity on how sanctuary jurisdictions are designated.

- **Flawed rollout**: DHS initially <u>released a list</u> of nearly 400 counties before removing it June 1, with no updates since.
- What counties want: The coalition is requesting clear criteria, an appeals process and guidance on how existing court orders are considered in federal decisions.

### Nebraska DHHS Opens Applications for Opioid Treatment Infrastructure Cash Fund Grant

The Nebraska Department of Health and Human Services (DHHS) Division of Behavioral Health is issuing a Request for Applications (RFA) for opioid use disorder (OUD) and/or substance use disorder (SUD) treatment infrastructure renovations, development, or expansion to enhance the Nebraska treatment system as outlined in Neb. Rev. Stat. § 71-2492.

Entities eligible to apply for grant funds include OUD and/or SUD treatment facilities, public-private, nonprofit, and for-profit entities.

"With the distribution of these funds, communities that have never received funding to build or expand treatment facilities may have the opportunity to do so now," said Dr. Thomas Janousek, Division of Behavioral Health Director. "This funding gives local areas the financial support they need to build spaces to better serve residents and improve treatment in their community."
