## **NACO Raises Concerns Over Ballot Proposals Threatening Local Services**

Recently filed petitions aiming to change Nebraska's property tax system could harm counties' ability to serve their communities. NACO has examined the dual petitions sponsored by Advocates for All Nebraskans and finds them to be ineffective in some ways and harmful in others. ## **Gov. Pillen Issues Disaster Declaration for 23 Counties Following August Storms**

**LINCOLN, NE** – Governor Jim Pillen has issued a disaster declaration for 23 counties resulting from storms that impacted the state earlier this month. Thunderstorms from Aug. 8 – 11 resulted in exceptionally high winds and heavy rain and caused significant damage to public property and infrastructure.

The Governor's declaration applies to the following counties: Burt, Butler, Cass, Dodge, Douglas, Fillmore, Gage, Harlan, Jefferson, Johnson, Lancaster, Nemaha, Nuckolls, Otoe, Pawnee, Saline, Sarpy, Saunders, Seward, Thayer, Washington, Webster and York. Estimated damage currently exceeds \$24 million. As a result, state funds can be directed to assist those areas as necessary.

## Inside Emergency Management: Celebrating National Emergency Management Awareness Month

NACO celebrated National Emergency Management Awareness Month in August by conducting Q&As with some of Nebraska's emergency management professionals. While the month may be ending, our elected officials' commitment to readiness continues year-round. [Head to our blog](#) to read all four installments of our Q&A series!

## Legislative Interim Studies Scheduled

The Legislature's standing committees have begun scheduling public hearings in September and October on interim study resolutions. Some resolutions are a deeper dive into bills that were introduced during the last session and others are ideas for bills that will be introduced in 2026.

Among the studies on issues affecting counties, on September 5, the Natural Resources Committee will hear [LR159](#), an interim study to examine the nameplate capacity tax rate and how it affects privately developed renewable energy in Nebraska.

Controlled burn permits will be examined on September 12 under [LR235](#).

On September 19, the committee will hear [LR225](#) that would examine the need for a Green Amendment that was proposed as [LR22CA](#) during the 2025 session. LR22CA, if passed by the Legislature and adopted by voters, would require the state and political subdivisions to serve as trustees for the state's natural resources.

Hearings are scheduled in October on the Open Meetings Act ([LR192](#)), unfunded mandates ([LR195](#)), county initiatives and referendums ([LR253](#)), and riparian weed control funding ([LR168](#)). A full list of hearing dates and locations can be found [here](#).

Some hearings are limited to invited testimony but public comments are accepted through the online comment button for each resolution.

## **Savi: August 2025 Policy Updates**

**The One Big Beautiful Bill (OBBB):**

This bill was passed on July 4th, 2025, and major changes to income-driven repayment plans are on the way and will begin on July 1st, 2026. Some of these changes include:

- Removing PAYE, ICR, and SAVE repayment plans and replacing them with a new Repayment Assistance Program (RAP). Enroll in one of these existing income-driven repayment plans today before enrollment ends in July.
- Borrowers already enrolled in one of these existing plans can remain enrolled through 2028.
- Savi recommends borrowers review their income-driven repayment plan options every few months directly through their [Savi account](#).
- Placing yearly and lifetime caps on the total amount a student can borrow, and limiting the availability of specific loan types (e.g., removing Grad PLUS Loans entirely).
- Removing the ability to enroll in certain forbearances and deferments (e.g., economic hardship and unemployment deferment), and limiting how much/often a borrower can use discretionary forbearance.

### **The SAVE Income-Driven Repayment Plan:**

- As of August 1, 2025, student loan interest began accruing again for the nearly 8 million borrowers enrolled in the Saving on a Valuable Education (SAVE) Plan.
- The future of the SAVE Plan remains uncertain. In the meantime, interest is now being added to loan balances, though forbearances that pause payments remain in effect.
- While no immediate action is required, borrowers looking to avoid accumulating interest may want to switch to an active repayment plan. You can explore your options and [enroll directly through your Savi account](#).


