KNOW ALL MEN BY THESE PRESENTS: That the undersigned, acting as incorporators of a corporation under the Nebraska Non-Profit Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I.

The name of the corporation is "WEBRASKA ASSOCIATION OF COUNTY OFFICIALS."

ARTICLE IE.

The period of its duration is perpetual.
