2026 NACO Scholarship Application Guidelines

1. Twelve scholarships in the amount of \$1,000 each will be awarded. Scholarships are awarded for one year only and are not renewable.
2. Children, stepchildren, and grandchildren of current Nebraska county officials or employees are eligible to apply for a NACO scholarship.
3. Applicants must be seniors attending an accredited Nebraska high school.
4. Applicants pursuing a career in nursing may be considered for the separate \$1,000 Ronda Dix Memorial Scholarship.
5. The scholarship may be used for any costs associated with continuing education including, but not limited to, tuition, books, fees, room and board. The scholarship applies to the first full semester or quarter of the 2026-2027 academic year. The scholarship may not be used for summer sessions or online-only educational institutions. NACO reserves the right to change in-person attendance requirements.
6. Applications must be postmarked on or before March 16, 2026. Applications postmarked after March 16, 2026 will not be considered. Scholarship recipients will be notified on or before May 15, 2026.
7. Recipients must attend a post-high school educational institution within the state of Nebraska.
8. Applicants must submit a seven-semester transcript.
9. Applicants must submit two essays of no more than 250 words each. One essay must be entitled "The Importance of County Government in Nebraska". The other essay must explain the applicant's career plans and future goals.
10. Applicants must submit two personal reference letters from persons who are not family members.
11. Applicants must sign the application and waiver authorizing inquiry into enrollment status. Incomplete or unsigned applications will not be considered. Recipients must sign a media release to allow publication of their photo and biographical information on the NACO website.
12. The scholarship selection committee may consider need, merit, achievements and other criteria deemed appropriate. Decisions of the scholarship selection committee are final.
13. Checks will be awarded after July 1, 2026 to the educational institution identified in the media release.
