NACo: White House signs Executive Order on State AI Lawmaking

On Dec. 11, President Trump [signed an executive order](#) aimed at mobilizing federal agencies to challenge existing state laws on artificial intelligence (AI), clarify legal scope for AI model

regulation at the state level, and condition federal funding on the non-enforcement of select state AI laws.

Federal policy framework: The order also calls on presidential advisors to prepare a legislative recommendation to Congress on a uniform federal policy framework for AI that preempts certain state AI laws.

Implications for counties: Counties urge against federal overreach of state and local AI lawmaking, while welcoming opportunities for counties to actively contribute to intergovernmental conversations on establishing a national policy framework on AI.

Reorganization Meetings to Occur in January 2026

In supervisor counties, the regular meetings of the county board are to be held in January. At its regular meeting of each year, the board must organize by choosing one of its number as chairman, who shall preside at all meetings of the board during the year; in case of his absence at any meeting, the members present must choose one of their number as temporary chairperson. Sections 23-272, 23-274. Similarly, Neb. Rev. Stat. § 23-156 provides the board of county commissioners at its regular meeting in January of each year must elect a chairperson of the board to serve for the ensuing year, and such chairperson shall sign all warrants on the treasurer for money to be paid out of the county treasury.

An individual can vote for himself or herself for county board chair. See [Nebraska Accountability and Disclosure Commission \(NADC\) Advisory Opinion #202](#), adopted by the Commission June 2017 addresses a series of questions related to conflicts of interest, financial gain and compensation. County board members may vote for themselves for the position of chair of the county board even if the chair has a higher salary. There are no "financial gain" and no conflict of interest involved in such a vote where the enhanced compensation for the chair is compensation provided by law.
