# **Attorney General's Opinion on Assessor Trespass**

Attorney General Mike Hilgers has issued the attached opinion (AGO 25-003) that affects

assessment practices in all counties.

This is the summary from the opinion:

County tax assessors are not exempt from the general law of trespass. A county tax assessor who enters private property without consent or a warrant therefore exposes himself to potential liability. Moreover, a county tax assessor who enters a home, or its immediately surrounding area, without a proper search warrant conducts an unreasonable search in violation of the United States and Nebraska Constitutions.

NACO will continue to examine this issue and the need for legislation to grant specific authority to assessors to enter private property.
