Nebraska Counties No Longer on Department of Justice Sanctuary Jurisdiction List

On May 30, the U.S. Department of Homeland Security (DHS) published a list of nearly 400 counties that they designated as "sanctuary jurisdictions," as part of the implementation of the <u>Protecting American Communities from Criminal Aliens Executive Order</u>.

In June, NACo, the International Municipal Lawyers Association, and the National League of Cities <u>sent a joint letter</u> to the Department of Homeland Security and the Department of Justice urging clarity on how sanctuary jurisdictions are designated.

On August 5, the U.S. Department of Justice published an <u>updated list</u> of sanctuary jurisdictions and an <u>explanation of the criteria for inclusion</u>. No counties in Nebraska are included on the updated list.

Lincoln County Commissioner Micaela Wuehler led the initial charge to assist Nebraska counties in being removed from the designation list. Commissioner Wuehler provides a more comprehensive breakdown of the year-long effort by NACO and county leadership to ensure accurate representation of Nebraska counties' adherence to federal immigration policy in a recent article by the North Platte Bulletin.

NACo - "The Big Shift: An Analysis of the Local Cost of Federal Cuts"

The recently enacted legislation, the *One Big Beautiful Bill Act* (OBBBA), and President Trump's Fiscal Year (FY) 2026 budget request signal significant changes to the federal, state, and local government partnership. While counties collaborate with federal and state partners

to deliver essential services, several changes — aimed at reducing federal costs — will shift financial and administrative costs onto subnational levels of government.

In a complex intergovernmental structure, these subnational governments, including counties, could see a downstream effect approaching \$1 trillion over ten years. This removal of longstanding federal funding sources and federal cost shift represents a fundamental swing in the intergovernmental partnership, potentially pushing counties to choose between cutting services or raising local taxes.


